# WWBIC'S IMPACT IN 2025

## 2025 Highlights

Impact numbers calculated 12/2025

In 2025, WWBIC served 4,373 unduplicated clients and almost 2,000 businesses across Wisconsin. Our work also assisted our clients in creating or retaining 4,484 jobs. We were also able to approve 66 loans for \$6.7 million, closing 47 of those loans for \$5 million. In conjunction with our many business partners, WWBIC was also able to provide over \$200,000 in grants that area businesses were able to use as equity to continue and grow their service to their local communities.

WWBIC also marked several significant milestones in 2025, including the Grand Opening of our North Central Office in Hayward, Wisconsin; welcoming our new President and Chief Visionary Officer, Kathryn J. Dunn; and earning the SBA Wisconsin's Award for the Community Advantage Lender with the most 7(a) loans approved during the year: the 13th time WWBIC has earned this award.

In addition, WWBIC celebrated our clients all year long through a Small Biz Market featuring over 80 clients at our annual luncheon; client pop-up markets; business plan and Make Your Money Talk graduations; pitch competitions; and more.

### Loan Financing Eligibility

If a potential borrower answers “yes” to the following statements, there is a good possibility they will qualify for a WWBIC loan.

- Do you have a written business plan?
- Does or will your business operate in the state of Wisconsin?
- Are you a start-up business owner with extensive experience in your industry?
- Do you own an established business with a successful track record, and you're ready to grow or expand?
- Do you have a good understanding of business operations practices (management, financing, human resources, marketing, etc.)?
- Do you have an explanation for any imperfections in your credit history such as low credit scores, collections or bankruptcies? (We invite all credit histories to apply!)

# KIVA LOANS

Kiva offers loans through an online crowd-funding platform, offering loans from \$1,000-\$15,000 at 0% interest and no fee.

Kiva is often the first step towards access to capital. Unlike traditional lending, Kiva's holistic social underwriting provides an opportunity to see beyond traditional lending requirements. Kiva does not require a minimum credit score, collateral, or a business plan. Kiva believes that successful businesses have rich community networks, are good at marketing their businesses, and are tech-savvy. Kiva loans provide an opportunity for businesses to establish business credit.

## HOW A KIVA LOAN WORKS:

### Step 1: Apply

Potential borrowers follow step-by-step application to create a profile that will be used in crowdfunding a loan. WWBIC provides support if needed.

### Step 2: Review

Kiva Capital Access Managers review applications and provide borrowers assistance prior to Kiva review. Kiva handles underwriting, establishes loan size, loan term and private lenders required.

### Step 3: Fundraise

For up to 45 days, individual lenders support borrower's loan for as little as \$25 through the Kiva platform.

**Private:** Borrowers are given 15 days to crowdfund within their personal network.

**Public:** Loan profiles are posted on Kiva website offering exposure to 2 million Kiva lenders worldwide.

### Step 4: Repay

Fully funded loans are disbursed electronically through PayPal. Repayments begin one month after receiving the loan. As borrowers make monthly loan payments, individual lenders are repaid.

WWBIC supports Kiva in Wisconsin, and our Kiva Capital Access Managers provide the personal touch to help borrowers through the application/loan life cycle.

From 2014 to 2025, WWBIC assisted 862 Kiva clients in securing \$6.12 million in loans!
